



## CombiMatrix Successfully Completes Transformational Merger with Invitae

### Torreyia Advised CombiMatrix on Merger

CombiMatrix Corporation (NASDAQ: CBMX), a molecular diagnostics company specializing in DNA-based reproductive health and pediatric testing services, has successfully completed its merger with Invitae Corporation (NYSE: NVTA). The transaction had a total enterprise value of approximately \$34.9 million.

Bringing together CombiMatrix's expertise in reproductive health and testing with Invitae's broader genetic-testing portfolio, the merger will help accelerate the use of genetic information in mainstream medical care.
